Highlights

ASSAULTS IN MARCH

AHMADIYYA MOSQUES

SOCIAL BARRIERS

In Peshawar, a non-Ahmadi doctor was killed during an attack on a clinic run by an Ahmadi. Another employee was wounded as well. Abdul Qadir, an Ahmadi doctor, was killed in a nearby medical facility last year. Five Ahmadis have been killed in Peshawar during the last two years.

In another incident in Taunsa Sharif, an elderly Ahmadi suffered serious head injuries. An Ahmadiyya mosque's roof has been burned in Badin, the same place where a local Ahmadi's wedding tents were torn down by enemies a month ago. There is a threat to another Ahmadiyya mosque in 275 RB, Kartarpur, Faisalabad, where the opponents have reported to authorities that Ahmadis have constructed a place of worship resembling a mosque.

An Ahmadi, named his shop after the name of his son. The TLP members gathered and forced him to remove the name from the front of the store. In addition, they harassed and threatened him. This was due to the name 'Abdullah', which means, 'Servant of Allah'. See similar details on pages 8 and 9, an insight into the difficulties Ahmadis face every day.

OATH OF KHATM-E-NABUWWAT FOR MARRIAGE REGISTRATION

Earlier we reported that the Punjab assembly has adopted a resolution to introduce an oath of Khatme-Nabuwwat to solemnize all marriages in the province under the Muslim law. A formal notification has been issued by the Governor this month. This notification provides an affidavit for the parties to prove their Islamic credentials. It contains the following sentence (Tr): "I consider Mirza Ghulam Ahmad Qadiani to be a Jhoota (false/liar/fabricator) Prophet." Ahmadis adhere to the principle of KN; however, the evil intended to its founder by the said oath must be condemned.

AHMADI'S CLINIC ATTACKED IN

PESHAWAR, LEAVING ONE DEAD

Bazid Khel, District Peshawar; March 5, 2022:

Two assailants entered the clinic here of an Ahmadi, Dr. Mansoor Ahmad. Both the attackers disguised themselves as patients; one of them covered himself with a veil (burga). He then opened fire. Dr. Muhammad Shahid Ahmad, a non-Ahmadi, who was sitting in place of Dr. Mansoor Ahmad, was shot dead on the spot. Another employee Mr. Jawad Ahmad was shot in the leg.

The killer also fired at other people in the clinic, but luckily they remained unhurt. The assailants then managed to escape.

Dr. Muhammad Shahid Ahmad was 35 years old. He left behind three mourning children and a wife. Dr. Sha-

hid was the son of Dr. Mansoor Ahmad's cousin. He was a very good person.

Last year, on February 11, 2021, Dr. Abdul Qadir, Ahmadi, was shot dead in a nearby medical center.

Five Ahmadis have been target-killed in Peshawar in a wave of hate campaign during the last two years.

AHMADI SURVIVES **ATTEMPT ON LIFE**

Taunsa Sharif, District D.G. Khan;

March 18, 2022: Mr. Abdul Latif, an Ahmadi runs an electrical shop. One Afzal aka Chanda entered his shop and struck him with a hammer — severely injuring him. He, however, survived.

The police were informed of the incident. They filed an FIR against the attacker and arrested him. He is now on judicial remand.

AHMADI ARRESTED

Rajanpur; March 2022:

Mr. Muhammad Abdullah is the sole Ahmadi in his family. His wife and three children are Ahmadis.

His wife got estranged from him and went to live with her parents who are not Ahmadi.

The husband and wife developed a dispute

about the temporary custody of the children. As a result, the wife arranged an incursion into his quarters, which proved futile. The in-laws went to court.

On March 4, 2022, oddly, the police, in a raid, arrested the Amir of Jamaat Ahmadiyya, District Rajanpur, perhaps for acting friendly to Mr. Abdullah.

THREAT TO AHMADIYYA PLACES OF WORSHIP

275 RB Kartarpur, District Faisalabad;

March 2022: Hafiz Rafaqat who leads prayers in another village, came along with two of his friends, took pictures of the two Ahmadiyya places of worship here. Later, it was learnt that he lodged a complaint with PCP (Pakistan Citizen Portal) that the Qadianis had built two mosque-style places of worship, and Islamic rites were used openly.

In addition, it was alleged that Quranic verses had been used on houses and graves; this had caused a strong wave of grief and anger among Muslims; therefore, legal action should be taken against them.


Ahmadis feel threatened and insecure.

AHMADIYYA MOSQUE'S ROOF PARTLY BURNED DOWN

Goth Ali Murad, District Badin, Sindh;

Jan-Feb 2022: On February 19, some unidentified opponents set fire to a wooden structure adjacent to the Ahmadiyya mosque in the village. The fire engulfed the Ahmadiyya mosque and half-burnt its roof. Locals came out to extinguish the fire to save the attached houses.

On January 23, another incident took place here. A day before the wedding of an Ahmadi girl, the wedding tents were torn open by unknown persons with a blade at midnight and set on fire. The Ahmadi family had to pay the cost of the damage to tents.

AHMADI BEATEN UP AND FORCED TO CLOSE DOWN BUSINESS

Shahzad Colony, District Faisalabad; March 2022:

Rashid Ahmad recently set up a junk shop in Rabbani Colony, and named it Abdullah Traders after his son Abdullah. On February 18, a bully entered his shop, objected to the shop's name (Abdullah Traders) and told Rashid to remove the poster. He called 15 to 20 men of TLP to the spot. They came, raised slogans and beat up Mr. Ahmad. They told him to take down the poster of his shop. When Mr. Ahmad climbed on a stool to do that, they pushed him off the stool, tore down the poster, and threatened him with registering an FIR.

Some people assembled there but, on learning of the Ahmadiyya identity of the proprietor, no one took a stand for him. In the mean-

time, Ahmad's brother reached the spot, closed the shop, and they went home.

Thereafter Tehreek-e-Labaik distributed leaflets of Tajdar Khatme Nabuwwat and asked the people of the area to boycott Mr. Ahmad and his family.

After two days of this incident, they held an End of Prophethood conference in the same neighborhood. They slandered Mr. Ahmad's son Mr. Shafiq Ahmad in the rally, and forced the shop owner to get his shop vacated.

Ahmad vacated the shop on February 21, 2022. Then, on February 25, an End of Prophethood conference was held again outside his house, where they used vulgar language against the Ahmadiyya Community.

BAIL AWAITED FROM SUPREME COURT

Lahore, March 2022:

Mr. MM Iqbal Hashmi, Mr. Shiraz Ahmad, and others were booked by Cyber Crimes Police Station Lahore on June 20, 2019, under FIR 88 under PPCs 295-A, 298-C, PECA-11 for allegedly creating the group 'Sindh Salamat' and sharing Ahmadiyya content in it.

Mr. Hashmi was arrested but was released on bail on August 24, 2019.

Mr. Shiraz Ahmad was arrested from his home on February 25, 2021.

One, Mr. Zahir Ahmad, Ahmadi from Lahore implicated in another religion-based case, was released on bail on February 23, 2021, but was immediately re-arrested in this case, although he was not even named in this case.

The plea for bail of the accused mentioned above was rejected on March 30, 2021.

The opponents opposed Mr. Hashmi's plea for bail, and an ASJ rejected the plea and ordered his arrest on August 9, 2021. Earlier, at the opponents'

request, Judge Syed Ali Abbas ASJ Lahore ordered that the deadly section PPC 295-C be added to his charge sheet.

As a result, all these three are incarcerated in Camp Jail, Lahore.

LHC heard the plea for bail and rejected it on January 12, 2022.

Iqbal Hashmi etc. case was initiated under PPC 295-A; however, with time, it is blown big with PPCs 295-C, and 295-B added to it that provide for the death penalty and imprisonment for life, respectively. Their plea for bail was then made to the Supreme Court.

A three-member bench of SC was appointed to hear the appeal against the decision of the High Court. SC issued notices to the parties on February 15, 2022, to appear on March 9, 2022. There was no proceedings due to the absence of the prosecutor because of his illness. It is years and months that these three Ahmadis are behind bars on religion-based charges.

AHMADIS APPROACH

THE SUPREME COURT FOR BAIL

Mr. Rohan Ahmad, Malik Usman Ahmad and Hafiz Tariq Shehzad, etc. were booked on May 26, 2020 with FIR Nr. 29/2020 at Police Station FIA Cyber Crimes Wing, Lahore under PPCs 295-B, 298-C, 120-B, 109, 34 R/W, 2016-PECA-11 allegedly for a quiz program concerning Ahmadiyya literature including the Holy Quran. The police arrested Mr. Rohan Ahmad, an Ahmadi religious teacher under this FIR on May 26, 2020.

Malik Usman Ahmad and Hafiz Tariq Shehzad were arrested on appearance in the FIA office; their plea for bail was rejected on September 30, 2020.

In response to a plea of the opponents, Addl. Sessions Judge Lahore added the deadly blasphemy clause PPC 295-C to the charge sheet on June 29, 2021. This exposes the accused to penalty of death.

On March 9, 2021, Additional Sessions Judge Lahore Hamid Hussain rejected their pleas for bail. They filed an appeal in the Lahore High Court against the decision, and Justice Muhammad Amjad Rafique rejected it on August 30. Thereafter they filed leave to appeal in the Supreme Court of Pakistan. Meanwhile, the trial of the case goes on in the court of Additional Sessions Judge Lahore.

The Supreme Court was scheduled to hear the bail application on March 9, 2022. A three-member bench of the apex court adjourned the case till next date due to non-availability of the complainant's lawyer.

IMPORTANT OBSERVATION

AND REMINDER — BY BILAWAL

Lahore; March 5, 2022:

The daily Dawn printed today a newsreport with the headline:

Bilawal links Peshawar blast (57 dead in mosque) to non-implementation of NAP. Alleges PTI government has soft corner for terrorists.

We produce below extracts from the report:

Lahore/Sahiwal: The Pakistan People's Party Chairman Bilawal Bhutto Zardari has condemned the Peshawar blast, blaming the government for not implementing the National Action Plan (NAP) to check terrorism in the country and accusing it of failing to establish the writ of the state by surrendering before terrorists.

Addressing the participants of the party's long march at Chichawatni's Rai Chowk, Sahiwal district, he said the incidence of terrorism had increased in the country as the Pakistan Tehreek-i-

Insaf government lacked the capacity to face the menace.

Why the blood of the masses is cheap and terrorists are roaming free in the country, while no action was being taken against them, the PPP Chairman asked the government.....

Note: The Government of Pakistan announced NAP in January 2015 to crack down on terrorism and to supplement the ongoing anti-terrorism offensive after the terrorist attack on Army Public School on December 16, 2014 in which 151 died including 132 children. After this massacre, there was a huge outcry against the atrocities of religious terrorism, and the politicians and military got on one page to take multi-pronged action against the terrorists. Mr. Nawaz Sharif was the prime minister; however, major political parties were on board. The NAP is an inclusive and readable document.

AN OVERVIEW OF THE SOCIAL BARRIERS AHMADIS FACE IN PAKISTAN - MARCH 2022

PREDICAMENTS OF A CONVERT

Sillanwali, District Sargodha; March 2022:

Mr. Qamar Abbas was in touch with Ahmadiyya Community since long. Eventually he decided to join the community two months ago. Mr. Abbas is the sole Ahmadi in his family. He had to face severe opposition after his conversion.

A man, who was tracking him for days, told Mr. Abbas's family of his switch over. At this, they turned against him and threatened him with con-

sequences. A local cleric announced his marriage null and void. The cleric gave him an ultimatum of three days to recant, or face arson at his house as well as other Ahmadis houses.

His relatives have imposed a societal boycott against Mr. Abbas. His wife and children are no longer staying with him.

PROPERTY RIGHTS DENIED ON DEMAND OF MULLAS

Silanwali, District Sargodha; March 2022:

Mr. Abdul Aziz, Ahmadi, has a property here, which he rented out to the medical college. The mullas have been protesting against this for some time now. Majlis Tahaffuze Khatme Nabuwwat complained to the Town Committee that Qadianis were going to construct a place of worship there. The administration promptly sealed the said property on mullas' demand.

Mullas then approached the WAPDA office and de-

manded that the electricity meter installed there be removed. They also invited mullas from Sargodha to join them in this drive.

Mr. Aziz contacted the concerned office to get the construction plan approved but they hesitated saying that they were under pressure from the mullas.

A higher office, however, has promised to do the needful.

TLP ACTIVISTS IN ACTION

Silhoke Chatha, District Gujranwala; March 2022:

Mr. Adeel Ijaz, an Ahmadi, resident of Rasool Nagar, District Gujranwala, ran a mobile shop in Silhoke Chatha. Tahrik-e-Labbaik (TLP) activists told him to vacate the shop; he had to comply. In anti-Ahmadiyya hatred, TLP activists washed the shop before setting up their office in it. TLP is busy

spreading hatred against Ahmadis in this village and inciting people against Ahmadis and urging their social boycott. They are planning to desecrate Ahmadis' graves in the common cemetery of the village.

TLP is the party that killed 8 policemen a few months ago in the Punjab.

A SAMPLE REPORT FROM THE EDUCATION SECTOR

Lahore; 2015-2021:

Ms. Faiza Ahmad, Ahmadi, had been teaching at Superior University since 2015 but had to resign on February 26, 2021 due to severe opposition.

Faiza faced opposition at the university for her faith. She was harassed in various ways. On days, she was maliciously assigned duty in the two campuses of the university at a distance of two kilometers. While she was doing her MSc, an attempt was made to block her distinctive success. She nevertheless stood first and won 'Gold Medal'. Her opposition escalated when a university teacher went to England for a PhD, and the head of the department accused Faiza of sending him to England after converting him to Ahmadiyyat. Other teachers also joined the head in this case and accused

Faiza of preaching Ahmadiyyat to students. A committee was set up to look into the matter, and they threatened Faiza that if the allegations were substantiated, she could be booked under PPC 298-C. In this situation, Faiza had to resign. When Faiza's boss saw her resignation, he said happily, "It was very painful for five years. Thankfully, it's over."

Faiza's brother Mujeeb Ahmad was a second-year student of UET when other students came to know that he was an Ahmadi. They started opposing Mujeeb, and at one occasion tried to strangle him. Similarly, Mr. Muzaffar Ahmad, the father of Faiza and Mujeeb, got a chance to study abroad, but someone informed the management of his Ahmadiyya faith. They sent someone else abroad in place of him.

ANTI-AHMADIYYA LECTURES AT GOVERNMENT SCHOOL

Rajanpur; February 27, 2022:

On February 26, local Majlis Tahaffuze Khatme Nabuwwat invited an anti-Ahmadi mulla Irfan Mahmood Barq to Rajanpur. On February 27, he held anti-Ahmadiyya sittings in different parts of the city, two of which were at the Government High School. The school assembled the students in the playground and mulla Barq delivered fiftyminute anti-Ahmadiyya lectures. He promoted

there his anti-Ahmadiyya book, "Radde Qadianiat (Rebuttal of Qadianiat), Islam or Science k katehry mein (in the courtroom of Islam and Science)".

On February 28, three motorcyclists came over to the shop owned by a prominent Ahmadi, stopped in front, passed information to someone by phone, made a video and departed.

HATEFUL WALL CHALKING IN HYDERABAD

Darul Barkat, District Hyderabad; March 2022:

Here a Pakhtun youth named Muhammad did wall chalking: 'Qadianis are infidel'. He is a madrassah student. Earlier, on 12th Rabi-ul-Awal, a news reporter gathered a few people in front of an Ahmadi's house and made provocative speech

against Ahmadis; its video is also available.

Ahmadis informed the administration; we are not aware of the follow-up.



DATH OF KHATME NABUWWAT IN NIKAH FORMS

PARTING PRESENT

BY RELIGIOUS BIGOTS

Lahore:

In October 2021, the Punjab Assembly unanimously adopted a resolution seeking inclusion of oath of Khatme Nabuwwat in the Nikah (marriage) documents. The Speaker later explained that it was very important to include such affidavit because some cases had been reported in the past that after marriage the groom turned out to be a Qadiani; as such all doubts and suspicions should be removed before the marriage takes place. The daily Nawa-i-Waqt, October 27, 2021.

Now a notification has been issued by the Governor that "he is pleased to make relevant amendments in the West Pakistan Rules under the Muslim Family Laws Ordinance 1962, with immediate effect."

We produce this Notification as Annex II to this report.

Para 4 of this Notification provides an Affidavit for the parties to prove their Islamic credentials. It contains the following sentence (Tr): "I consider Mirza Ghulam Ahmad Qadiani to be a Jhoota (false/liar/fabricator) Prophet."

It may be asserted authoritatively that never in the past 14 centuries, anywhere else, a Muslim was identified formally by this affidavit or by the definition of Khatme Nabuwwat mentioned in it. It is an innovation. Also, it is bizarre, inappropriate, and unethical to uphold your religious identity by calling bad names to the holy personages of people of another belief or denomination.

The Ahmadiyya Community adheres to the principle of KN; however, it strongly condemns the abuse aimed at its founder in the said KN oath.

This affidavit will have to be signed by the bridegroom, the bride, the witnesses to the Nikah ceremony, the official who administers the Nikah and the registrar of the Nikah.

In addition, it is relevant to point out that through this affidavit the government has made it mandatory that the registrar of marriages would have to be a legal Muslim. It is obvious, that the registrar's post is a clerical one, and one of any religious beliefs should be able to handle it. This reminds one of another Punjab Government order in the recent past that all teachers of Arabic language will have to be of Islamic faith.

On the issue date of this Notification, Mr. Pervaiz Elahi was the Speaker, Mr. Usman Buzdar the Chief Minister and Ch. Muhammad Sarwar the Governor of the Punjab.

Within two weeks, both the governor and the chief minister had lost their job while Mr. Elahi was not elected to his coveted post of the chief minister.

INTERNATIONAL BODY'S STATEMENT ON AHMADIYYA SITUATION WORLDWIDE

IRFBA, March 1, 2022:

IRFBA stands for International Religious

Freedom or Belief Alliance. Its following members are Ex-signatories to a Statement on the "Ahmadiyya Muslim Community": Australia, Brazil, Croatia, Czech Republic, Denmark, Israel, the Netherlands, Norway, Poland, Slovak Republic, Sovereign Order of Malta, the United Kingdom and the United States.

Although the statement addresses all countries in the world that need to improve their treatment of Ahmadis in their midst, its principal and direct unnamed addressee is

Pakistan, as it is in Pakistan that Ahmadis, as mentioned therein:

- Are held prisoners for exercising their religious belief for being blasphemous and self-identification as Muslims
- Are denied their right of vote through special provisions in law
- Suffer raids on their places of worship
- Are discriminated with respect to the issuance of national identification

documents, etc. etc.



MULLA TASKS POLICE TO UNDERTAKE EVIL

Peeru Chak, District Sialkot; January-March 2022:

Anti-Ahmadiyya wall chalking was done here at various places and a couplet was written in front of the Ahmadiyya mosque: "Tell me what you want? Head of a blasphemer!" Ahmadis informed the police; the SHO PS Motra came and removed it. Thereafter the situation worsened for Ahmadis. Wall chalking was done again in the village, and the authorities effaced it.





Bilal Butt, an Anti-Ahmadi activist of Tahaffuze Khatme Nabuwwat, filed a complaint with PS Motra against Ahmadis, Messrs. Yaqub Ahmad Dogar (local Ahmadiyya president), Maqsood Ahmad Dogar, Abdul Khaliq, Jameel Ahmad, Malik Abdul Salam, Muhammad Yaqub and Ghulam Mohi-ud-Din for allegedly violating anti-Ahmadiyya sections PPCs 298-B, 298-C.

On March 24, the locals went to the neighboring village and announced there to go to Peeru Chak to help Islam by prosecuting Qadianis. These opponents went to see DSP Daska with accusation that Qadianis had used Islamic rites.

On March 28, the SHO police came to the graveyard and desecrated Ahmadis' tombstones along with locals. Ahmadis asked him to show the formal orders. At this, the police quit and left. They had desecrated two Ahmadis' tombstones.

Did you know!

92 graves of Ahmadis were desecrated & sacred inscription from atleast 16 houses and shops were removed during 2021.
47 graves have been desecrated in

the first quarter of 2022.

ANTI-AHMADIYYA CONFERENCE

IN CHINIOT

Chiniot; February 26-27:

The 60th Fateh Mubahila Conference was held on 26-27 February 2022 in Chiniot. Mulla Abdul Ghafur (General Secretary International Khatme Nabuwwat Movement Sindh), Mulla Zahid Al-Rashidi of Gujranwala, Qari Ahmad Ali Nadeem (President Khatme Nabuwwat Pakistan), Syed Kafeel Shah Bukhari of Multan, Mulla Shahid Imran Arafi of Sahiwal, Mufti Tahir Masood of Sargodha, Mulla Ilyas Chinioti MPA and some other politicians including Hafiz Ammar Yasir (Minister for Minerals, Punjab), Capt. (R) Safdar (PML-N, son-in-law of Mr. Nawaz Sharif), Ikhtiar Wali Khan (MPA, Khyber Pakhtunkhwa), Bilal Tariq Tarar (MPA, Lahore) and Ghulam Muhammad Lali (MNA) participated.

During the conference, the mullas stated that Qadianis who have strayed from Islam are invited to Islam by believing in the finality of prophethood and thus become entitled to the pool of Kausar on doomsday. Pakistan's nuclear assets are not safe without removing the Qadianis from key posts. The silence of human rights organizations on the violation of basic human rights by Qadianis in Chenab Nagar is beyond comprehension. The intent to take control of any religious seminary in the country, including Islamabad, will not be allowed to succeed under any circumstances, they asserted.

On this occasion, they approved the following resolutions:

- This Ijtema (conference) pays homage to the male and female members of provincial assemblies from Khyber Pakhtunkhwa and Punjab who have included the affidavit of Khatme Nabuwwat in the marriage form.
- This ljtema demands column of religion in the identity card.
- This Ijtema demands from the Punjab government that a third party audit of the so-called Qadiani welfare organizations be carried out and the 1034 kanals of land purchased by Qa-

dianis in Chenab Nagar be demarcated.

This litema declares that insulting of the Prophets, Companions, Ahle Bait and other holy persons, by Qadianis and the non-religious on social media be treated as terrorism. Legal action should be taken against them.

FAIR VERDICT OF THE SUPREME COURT

Islamabad:

Honourable Supreme Court of Pakistan, a two-member bench comprising Justice Syed Mansoor Ali Shah and Justice M Amin Khan, in a verdict overturned orders of lower courts and the Lahore High Court that could have set a dangerous and unjust precedence in prosecution of Ahmadis.

Briefly, three Ahmadis of Shaukat Abad, District Nankana were booked under anti-Ahmadi laws in 2020 and were arrested. One of those three accused died during his incarceration. The other two were released on bail, however, they remained under trial.

On-demand of the opponents, a magistrate ordered that PPCs 295-C and 295-B be added to the charge sheet. These sections provide penalties of death and imprisonment for life respectively. The magistrate based his decision on the wrong presumption that Ahmadis, while reciting the Kalima, consider their founder to be the Muhammad PBUH.

Thereafter, Sessions Judge Nankana upheld the magistrate's decision on May 3, 2021. Ahmadis appealed to the high court against this decision. Justice Farooq Haider endorsed the entire verdict of the Sessions Judge, and dismissed Ahmadiyya petition.

This decision conveyed in principle that any Ahmadi who recites the Kalima (Islamic Creed) or is in possession of the Holy Quran is guilty of blasphemy against the Holy Prophet and the Holy Quran. In the written verdict the Ahmadiyya place of worship was termed an 'unholy place.' This was a matter of great concern, as it exposed all Ahmadis to great harm. So, Ahmadis appealed against it in the Supreme Court.

The Supreme Court issued a written verdict on March 24, 2022. It observed that the trial and the revisional courts had not correctly examined the ingredients necessary to constitute the offences punishable under sections 295-B and 295-C and the petition was therefore converted into an appeal and allowed. Accordingly, sections PPC 295-C and 295-B added to the charge sheet were removed.

The honorable judges issued a 9-page verdict Crl. P.916-L/2021 (against the order dated 24.5.2021 of Lahore High Court, Lahore passed in Crl. Misc. No. 31929 of 2021). This worthy verdict is very readable as it clarifies a number of unfair assumptions and positions against Ahmadis. The judges rightly pointed out: "Article 260(3) of the Constitution though declares the Ahmadis/Qadianis as non-Muslim, it neither disowns them as citizens of Pakistan nor deprives them of their entitlement to the fundamental rights guaranteed under the constitution." (Para 12)

AN EXCEPTIONAL SHO!

Chak 96 GB, Sarih, District Faisalabad; March 17, 2022:

The police sent for the heads of five Ahmadi families resident here, and told them that they had received a complaint against them for using Islamic rites on the gravestones of their deceased. This includes the use of Bismillah and names such as Ali and Muhammad etc.

An Ahmadiyya delegation went to the police station. There, opponents including the complainant Saqib, president of the local TLP, were present. The Station House Officer of the police station (SHO) heard the views of both the parties. One of the opponents said that Ahmadis cannot use Bismillah

and names like Hasan, Hussain and Muhammad etc. Also, they use Islamic rites on their cars, motorcycles and houses. "If we stop them, they pose to be oppressed; so we have come to the administration", he added. The SHO explained that on receipt of the complaint, he studied the Constitution and contacted a couple of legal experts. There is no restriction on Ahmadis for using Bismillah and the mentioned names. If there was a restriction, NADRA would not have issued them ID cards with these names, he asserted. The SHO told the opponents to come up with some constitutional reasoning; in that case, he would remove those unconstitutional Islamic inscriptions.

ISLAMOPHOBIA,

IMRAN KHAN — AND AHMADIYYAT

March 2022:

The UN General Assembly passed a Resolution, introduced by Pakistan, to recognize March 15 as the International Day to combat Islamophobia. It was generally lauded in the backdrop of global hate crimes and state-sanctioned bias against Muslims.

Mr. Imran Khan, who is in dire straits these days did not let the event pass without drawing his extra liter of milk from the political cow. He said the following the next day in a public gathering at Swat (Tr):

"This after 1973...In 1973, Pakistan's National Assembly decided that those who do not consider our Prophet as the last Prophet are not Muslim. The 1973 Assembly decided this. They decided that Qadianis who do not believe in the finality of our Prophet (PBUH) are non-Muslim; they are a minority. This (UN Resolution on Islamophobia) is the biggest achievement for the Muslim world since then. Today the UN has accepted that the world should raise its voice against Islamophobia. 15th March has been declared as the day of Islamophobia every year."

In our opinion, it is unfortunate that Mr. Khan chose to put this laudable UNGA Resolution in the same category as the 1974 anti-Ahmadiyya Amendment Nr II to the Pakistan Constitution, which stands, decades later, condemned by most scholars of civics and political science including some from the PPP whose leader ZA Bhutto sponsored this Amendment.

Mr. Khan is proud of getting a resolution passed against Islamophobia, while simultaneously he is proud of the constitutional amendment





that gave birth to, promoted and nourished Ahmadiphobia in the land. This is obvious incongruity. If Islamophobia has put Muslims' lives at risk and generated discriminatory treatment of Muslims in the field of social justice, jobs, business, education, worship, etc, the Amendment II has resulted in promulgation of Ordination XX, scores of Ahmadis murdered for their faith, serious violations of Ahmadis' religious freedom and human rights and blatant discrimination in voting rights, jobs, education etc. Referring to the Ahmadiyya situation in Pakistan, International Humanist and Ethical Union conveyed to the UNHRC in 2010: "Need we remind the Council and the government of Pakistan that it was government and media support for expressions of hatred that led to the Nazi Holocaust and the genocide in Rwanda."

We are not alone in taking note of Mr. Imran Khan's freak; many took to Twitter to express their censure. We reproduce here only three (from academia):

@SaleemudDinAA: World connecting Islamophobia with religious discrimination is not equally wrong?

West has Islamophobia, but we have resolved religious bigotry by ousting a whole community from the fold of Islam. Bravo

RETURN OF CARNAGE,

AND AHMADIS

Peshawar/Islamabad:

Thus wrote the daily Dawn on March 5, 2022:

"A pall of gloom hangs heavy in Pakistan. Peshawar's fragile peace — which was at times tested, but had largely endured for the past few years — was rent asunder yesterday by the indiscriminate slaughter of Shia worshippers gathered for weekly Friday prayers. As the faithful packed the halls of a mosque in the provincial capital's Kocha Risaldar area for the congregation, at least one attacker shot his way inside the place of worship before detonating a vest rigged with explosives. At the time this paper went to print, hospital sources had confirmed 57 dead and more than 190 injured...."

The Dawn concluded thus its editorial with very suitable advice:

"Yesterday's attack, grave tragedy that it is, also represents a significant setback for those who have been working to change how Pakistan is perceived internationally. There needs to be a rethink of national security policy regarding outfits that target communities for their beliefs, as well as those that enable and encourage them to further their hateful agendas in the name of some misguided ideology."

Well, Ahmadis are such a community, and there are outfits that target them openly for their beliefs. In October 2021, Aalami Majlis Tahaffuz Khatme Nabuwwat (AMTKN) held a big open-air rally in Rabwah, where Ahmadiyya community's national center is located; there, the speakers spewed the following hateful statements inter alia, that comprised lies, slander, threats etc:

"Qadiani community comprises liars...In the near future Qadianis will flee from Pakistan", said Mulla Irshad of Muslim Colony in 1st Session on October 27

"We will crush the villain who commits robbery against the belief in KN," said Mulla Abdul Razzaq in 1st Session on October 27.

"The US and allies waited to destroy Afghanistan and the beard, but they themselves met disgrace. Qadianis similarly will be disgraced and will flee from Pakistan," said Mufti Azamtullah of Bannu in 2nd Session on October 27.

"Mirza Qadiani is the worst man anywhere. We are not acquiring Kashmir because of Qadianis. Bangladesh too got separated because of them," said Mulla Abdul Shakoor of Faisalabad in the third Session on October 28.

"Imran Khan's government would like Pakistan to become a Qadiani state, but we'll not let that happen. Qadianis consider the British to be their patrons. Mirza Qadiani, in order to please the British, declared Jihad to be haraam (unlawful in Shariah); we'll not allow this conspiracy to succeed," said Mulla Mujibur Rahman of Sheikhupura in fourth Session on October 28.

"O Qadianis, we will chase and crush you all over the globe. You are traitors to the Constitution and robbers of Khatme Nabuwwat (KN). It is not distant future when all of you will flee from Pakistan," said Mulla Zahid Qasimi in the third Session on October 28.

Finally yet importantly, a quote from Maulvi Fazl ur Rehman (JUI-F) who is a regular visitor to anti-Ahmadi rallies: "Qadianiat is a great evil (fitna) in the Sub-continent; it must be crushed. God has chosen us to safeguard the belief in Khatme Nabuwwat."

These threats are not empty threats. These convey their wishes and design. In 2010, a group of terrorists attacked Ahmadi worshippers in two Ahmadi mosques in Lahore and killed 86 Ahmadis and one Christian. In the recent past, Ahmadis have been murdered in Peshawar in targeted attacks. Also the very next day after the massacre in Shia mosque in Peshawar, the terrorists attacked an Ahmadi's clinic in the same city and killed one person.

Because of such hateful violent extremism, hundreds of Ahmadis have been target-killed in Pakistan since promulgation of anti-Ahmadi Ordinance XX.

As for those who enable and encourage them to further their hateful agenda, as mentioned in the Dawn editorial, it is on record that district authorities themselves permitted, facilitated, enabled and supported the AMTKN rally mentioned above. They, of course, receive their policy instructions from Lahore, where the executives get their orders from Islamabad.

Mr. Rohan Ahmad, Malik Usman Ahmad and Hafiz Tariq Shehzad, etc. were booked on May 26, 2020 with FIR Nr. 29/2020 at Police Station FIA Cyber Crimes Wing, Lahore under PPCs 295-B, 298-C, 120-B, 109, 34 R/W, 2016-PECA-11. Pakistan's Cyber Crimes Department, Lahore that works under Federal Investigation Agency arrested Mr. Rohan Ahmad.

Malik Usman Ahmad and Hafiz Tariq Shehzad were arrested on appearance in the FIA office; they are in Camp Jail Lahore. Syed Ali Abbas, Addl. Sessions Judge Lahore added the deadly blasphemy clause PPC 295-C to the charge sheet on June 29, 2021. Thus, they are now exposed to penalty of death. Their post arrest bail Petition is pending before the Supreme Court.

Mr. Muhammad Mahmood Iqbal Hashmi, Mr. Shiraz Ahmad etc. were booked by Cyber Crime Police Station Lahore on June 20, 2019 under FIR Nr. 88, under PPCs 295-A, 298-C, PECA-11, for allegedly creating a group "Sindh Salamat" and allegedly sharing Ahmadiyya content in it. Mr. Shiraz Ahmad was arrested from Hafizabad on February 25, 2021, while Mr. Hashmi was re-arrested on August 9, 2021 after cancellation of his bail.

Mr. Abdul Majeed s/o Mr. Abdul Waheed resident of Shaheen Muslim Town, Taj Chowk, Phandu Road, District Peshawar, aged 20, was accused of blasphemy by a minor named Mr. Imran Ali. The police succumbed to the pressure of the mullas and registered a fabricated case against him under section 295-C of the Pakistan Penal Code, 1860 which carries a sentence of death, on September 10, 2020 with FIR Nr. 648 at police station Phandu, Peshawar. He was arrested on 13.09.2020. He is currently in Peshawar Jail.

4

Malik Zahir Ahmad was arrested on September 30, 2020 in a fabricated case under Sections 298-C, 295-B PECA-11 and 109. He was granted bail on February 23, 2021 and was expected to be released in four to five days after paper formalities. On February 27, when Malik Zahir Ahmad was expected to be released from the Camp Jail, the Cyber Crime Wing Lahore team arrested him under FIR Nr. 88 as outlined in the above case, under PPCs 295-A, 298-C, PECA-11. He was not even formally nominated in the case.

As of March 31, 2022:

- 7 Ahmadis are behind bars solely on account of their faith.
- A local Ahmadi leader arrested in March 2022.
- A 65 year old Ahmadi lady and another Ahmadi were arrested under blasphemy clauses during February for allegedly tearing off an anti-Ahmadiyya poster.
 They both were released on bail. Their trial continues.
- A 20-year-old Ahmadi student is in jail under PPC 295-C (blasphemy clause).
- 2 Ahmadi prisoner died while in police custody (Feb. 2021 & Jan 2022.)

Despite fulfilling all terms and conditions, and regardless of repeated requests and numerous reminders, the community's institutions are not denationalized.
- The entire population of Rabwah i.e. Ahmadiyya headquarters in Pakistan, was charged under section PPC 298-C on Dec. 15, 1989, and again on June 8, 2008. (Rabwah population is approximately 60,000.)
- The government has banned all outdoor rallies & conferences of Ahmadis in Rabwah.
- The government of Punjab has banned the publishing of the Quran and its translation
- The government of Punjab has banned the entire written works of the Founder of Ahmadiyyat.
- Ahmadiyya daily newspaper and periodicals for women, youth, children and elders were banned by a Punjab government notification.

ANNEX I

ISLAMABAD: The top court has noted that bigoted behaviour towards minorities painted the entire nation in poor colour, labelling people of Pakistan as intolerant, dogmatic and rigid as it overturned a Lahore High Court order, which had endorsed the charges of blasphemy against members of the Ahmadiyya community on the allegation that they had styled their place of worship as a mosque and displayed Islamic symbols on its inner walls.

"To deprive a non-Muslim (minority) of our country from holding his religious beliefs, to obstruct him from professing and practicing his religion within the four walls of his place of worship is against the grain of our democratic Constitution and repugnant to the spirit and character of our Islamic Republic," read nine-page judgment, authored by Justice Syed Mansoor Ali Shah, who was heading a division bench hearing a petition against the offence of blasphemy on Ahmadi individuals.

It was also alleged that the electricity bill of the Ahmadi place of worship described it as a mosque. On these allegations, the petitioners were put to trial. On November 23, 2020, the trial court had framed the charge against the petitioners for offences punishable under Sections 298-B and 298-C of the PPC. Later, the complainant filed an application under Section 227 of the CrPC for alteration of the charges. He claimed that offences punishable under Sections 295-B and 295-C PPC were also attracted and should be added to the charges.

The LHC also endorsed the inclusion of blasphemy charges against the petitioners.

The apex court posed the question as to that whether or not the allegations levelled in the crime report and the material collected in the course of the investigation attracted the commission of offences punishable under Sections 295-B and 295-C of the PPC.

The judgment noted that observations of this court and of the Federal Shariat Court were in line with the constitutional values enshrined in the preamble to constitution which require citizens to be tolerant as a people, believe in freedom, equality and social justice, and respect minorities and make adequate provisions for them to freely profess and practice their religions and develop their cultures and to safeguard their legitimate interests.

The court noted that even though Article 260(3) of the Constitution declared Ahmadis as non-Muslims, it neither disowned them as citizens, nor deprived them of their entitlement to their fundamental rights.

The court observed that to constitute an offence under Section 295-B, the reading thereof showed that the accused must have defiled, damaged or desecrated a copy of the Holy Quran or an extract therefrom or use it in any derogatory manner or for any unlawful purpose.

"There is no allegation in the crime report that attracts the said offence. The courts below have held that the mere reading of the Kalima or the Holy Quran by a non-Muslim/Ahmadi attracts Section 295-C. This, in our view, is not only far-fetched, but also fails to meet the fundamental constituents of the crime, i.e., mens rea and actus reus. Only that which resides in the mind of a non-Muslim while reading the Holy Quran is not sufficient to constitute the offence."

Similarly, the court added, to constitute an offence under Section 295-C of the PPC, there must be words spoken or written or by visible representation or any imputation, innuendo or insinuation, direct or indirect, which defiled the sacred name of the Holy Prophet Muhammad (PBUH).

"In the instant case, the display of the Kalima and having the name of the Holy Prophet Muhammad (PBUH) inside the place of worship do not attract the constituents of the said offence."

The verdict read what ran inside the mind of an Ahmadi while reading the Kalima did not constitute an offence punishable under Section 295-C of the PPC unless there was some overt act on his part that defiled the sacred name of the Holy Prophet Muhammad (PBUH).

The court observed that the trial and revisional courts had not correctly examined the ingredients necessary to constitute the offences punishable under sections 295-B and 296-C PPC and the petition was therefore converted into an appeal and allowed.

"The impugned order is reversed, the petition of the petitioners under Section 561-A CrPC is accepted and the orders of the trial and revisional courts are set aside. The trial of the petitioners shall proceed on the basis of the charge framed on 23.11.2020 only for offences punishable under Section 298-B and 298-C of the PPC.

AMENDMENTS

- For the words "West Pakistan", wherever appearing, the words "the Punjab" shall be substituted.
- In rule 1, for the words "West Pakistan Rules under the Muslim Family Laws Ordinance", the words "Punjab Muslim Family Rules" shall be substituted.
- 3. In rule 2:
 - (a) In clause (c), the word "and" appearing at the end shall be omitted; and
 - (b) after clause (c), the following clause (ca) shall be inserted:
 - "(ca) "rules" means the Punjab Muslim Family Rules, 1961; and".
- In Form II, after Sr. No. (25), the following Sr. No.(26) shall be inserted:

IRFBA statement on the Ahmadiyya Muslim Community

As members, friends, and observers of the International Religious Freedom or Belief Alliance, we note with grave concern the hostility toward the Ahmadiyya Muslim Community in a range of countries, and the threats to the human right to freedom of religion or belief (FoRB) for members of this community. For Ahmadi Muslims, as for all individuals everywhere, freedom of religion or belief includes having the ability to affirmatively define or identify their religious beliefs.

We note, for example, that some state authorities prevent Ahmadi Muslims from self-identifying as they so choose, restricting their ability to worship, prosecuting them for practicing their faith, and tolerating attacks against them by non-state actors. Au-

thorities frequently use laws on offences relating to religion (blasphemy laws) to target these individuals, preventing Ahmadi Muslims from exercising their rights to freedom of religion or belief, to freedom of expression, and other human rights. In addition, some state authorities have threatened to charge Ahmadi individuals who reside in IRFBA member countries and other third countries with blasphemy for posting Ahmadi web content and threaten organizations who host it with legal action.

We also note with deep concern significant societal hostility toward Ahmadis in far too many countries.

We affirm that the right to FoRB, in accordance with Article 18 of the Universal Declaration of Human Rights, includes the freedom to manifest an individual's religion or belief in teaching, practice, worship and observance. States should not, therefore, discriminate against and tolerate violence toward Ahmadi Muslims – or anyone – based on their interpretation of the Islamic faith. We call upon all states to, where applicable:

- Immediately release all Ahmadi Muslims imprisoned for exercising their religious beliefs, including on charges on the grounds of their religious expression (for example, blasphemy), activities, and self-identification as Muslims;
- Immediately re-instate the right to vote to Ahmadi Muslims;
- Immediately end capital punishment of Ahmadi Muslims pursuant to blasphemy laws;
- Immediately end home raids and raids on places of worship for Ahmadi Muslims;
- Immediately eliminate any discrimination against Ahmadi Muslims with respect to the issuance of national identification documents;
- Immediately eliminate any discrimination against Ahmadi Muslims with respect to their access to justice within courts and hearings;
- Immediately eliminate discrimination against Ahmadi Muslims with respect to their employment and education;
- Immediately eliminate targeting Ahmadi Muslims in third countries under laws that curb free expression, including religious expression, and bans on their religious texts, online and offline;
- Review and address current intersecting forms of violence and discrimination against women and children of the Ahmadiyya Muslim Community*; and
- Hold accountable individuals and groups who use violence or intimidation against Ahmadis.

^{*}Chair's explanatory statement: For clarification this refers to violence and discrimination by state actors against Ahmadi Muslim women and children.

THE AHMADIYYA MUSLIM JAMA'AT IS A RELIGIOUS COMMUNITY AND ORGANIZATION, INTERNATIONAL IN CHARACTER, WITH ESTABLISHED BRANCHES IN OVER 210 COUNTRIES AND TERRITORIES IN ASIA, AFRICA, THE AMERICAS, EUROPE AND AUSTRALIA. IT HAS TENS OF MILLIONS OF MEMBERS WORLDWIDE AND IS GROWING. THE AHMADIYYA COMMUNITY WAS FOUNDED IN 1889 BY HADRAT MIRZA GHULAM AHMAD OF OADIAN, ON TEACHINGS THAT HE SAW AS AN EMBODIMENT OF THE BENEVOLENT MESSAGE OF ISLAM: PEACE, UNIVERSAL BROTHERHOOD, AND SUBMISSION TO THE WILL OF GOD. HE CLAIMED TO BE THE LATTER-DAY MESSIAH AND REFORMER AWAITED IN LEADING WORLD RELIGIONS OF THE WORLD. HE OPPOSED VIOLENCE AS A MEANS OF ADVANCING RELIGION AND REJECTED TERRORISM IN ANY FORM OR FOR ANY REASON.

DECLARING AHMADIS AS NON-MUSLIMS

THE PAKISTANI RELIGIOUS ESTABLISHMENT BRANDS THE AHMADIYYA COMMUNITY HERETICAL IN NATURE AND DOES NOT APPROVE OF ITS REFORMATORY NATURE. POLITICIANS HAVE ALSO FOUND IT EXPEDIENT TO SUPPORT THE RELIGIOUS ESTABLISHMENT IN THEIR ANTI-AHMADIYYA STANCE. THE FIRST COUNTRYWIDE WAVE OF VIOLENCE AGAINST THE COMMUNITY ERUPTED IN 1953. FOLLOWING THE EXTENSIVE RIOTS, AN IN-DEPTH JUDICIAL INQUIRY BY THE CHIEF JUSTICE AND A JUDGE OF LAHORE HIGH COURT FOUND POLITICS TO BE THE MAIN CAUSE OF DISTURBANCES. MANY YEARS LATER, IN 1974, MR ZULFIKAR ALI BHUTTO, THE THEN PRIME MINISTER OF PAKISTAN, FOUND IT POLITICALLY ADVANTAGEOUS TO HAVE AHMADIS DECLARED A NON-MUSLIM MINORITY, WHICH IN PAKISTAN IS A FORM OF SECOND RATE CITIZENSHIP. IT WAS A UNIQUE INNOVATION; WHILE OTHER NON-MUSLIM RELIGIOUS GROUPS, LIKE CHRISTIANS AND HINDUS, WERE NON-MUSLIM MINORITY BY THEIR PROFESSION, AHMADIS WERE FORCIBLY DECLARED A NON-MUSLIM MINORITY THROUGH LEGISLATION.

ORDINANCE XX

FOLLOWING BHUTTO'S LEAD, GENERAL ZIA UL HAQ, THE MILITARY DICTATOR OF PAKISTAN FROM 1977 TO 1988, TRIED TO COURT EXTREMISTS BY PROMULGATING THE NOTORIOUS ANTI-AHMADIYYA ORDINANCE XX IN 1984. THE ORDINANCE ADDED SECTIONS 298-B AND 298-C TO THE PAKISTAN PENAL CODE. THROUGH THIS ORDINANCE, THE RELIGIOUS RIGHTS OF AHMADIS WERE DIRECTLY VIOLATED. UNDER ITS PROVISIONS, AHMADIS COULD BE IMPRISONED FOR THREE YEARS AND FINED AN ARBITRARY AMOUNT FOR ORDINARY EXPRESSION OF THEIR FAITH. ADDITIONALLY, TO PROHIBIT AHMADIS FROM PROSELYTIZING, IT EXPRESSLY FORBADE THEM FROM CERTAIN RELIGIOUS PRACTICES AND THE USAGE OF ISLAMIC TERMINOLOGY. THIS ORDINANCE EFFECTIVELY MAKES A CRIMINAL OUT OF EVERY AHMADI BY INCLUDING THE BROAD PROVISION OF "POSING AS A MUSLIM" A COGNIZABLE OFFENCE, GIVING THE EXTREMISTS À CARTE BLANCHETO TERRORIZE AHMADIS WITH THE BACKING OF THE STATE.
